Role Purpose

The Primary PSHE Adviser will provide high quality advice, guidance, support and training across Camden primary schools, working with PSHE Coordinators, Senior Leaders and partners in Camden Council and external organisation, to continue to improve PSHE provision and contribute to improving pupil's health and wellbeing. The role will champion the sharing of good practice across schools and the development of high quality and innovative practice.

The Primary PSHE Adviser will

- Lead on the development and delivery of work to support PSHE in primary schools to meet the national curriculum requirements, through advice, support, guidance and training
- Provide support to PSHE Coordinators to develop their skills and confidence to lead PSHE effectively and facilitate the sharing of good practice between schools
- Identify, evaluate and share creative and accessible resources and develop guidance that will improve the provision of PSHE
- Work with school staff and Leadership Teams to identify areas for development and improve provision for PSHE, and plan support accordingly
- Work with partners across Camden Council, external organisations and agencies and health professionals as appropriate to support the development of PSHE in primary schools
- Provide support and challenge to primary schools to achieve and maintain Healthy School awards, including Healthy School London silver and gold
- Provide operational and strategic advice to the Health and Wellbeing Team, colleagues in Camden Learning and the wider Council in order that Camden Learning is at the forefront of thinking and developments regarding PSHE
- Carry out any other duties commensurate with the grade of the post, as may be required

Qualification requirements

- Degree level qualification or professional qualification relevant to the post
- Evidence of wide ranging and relevant continued professional development

Person Specification

- Evidence of specialist and up to date knowledge of effective practice in PSHE provision and national guidance
- Proven successful experience of leading and/or teaching PSHE
- Experience of supporting others to develop and improve effective PSHE practice
- Ability to inspire and support others to develop their practice

- Experience of successful working with a range of stakeholders such as Senior Leaders, teachers and support staff, governors, parents and carers and relevant partner organisations, such as Camden Council, PSHE providers
- Confident in the use of IT
- Excellent interpersonal skills, with the ability to communicate at all levels and engenders the confidence of schools and partners
- Ability to work in teams and work collaboratively with others
- A proven commitment to supporting and promoting equal opportunities and inclusive practices
- Ability to monitor, evaluate, analyse and utilise findings effectively

Work Environment:

- The main base of work is the Camden Council Offices at 5 Pancras Square, though the post holder may be able to work remotely for some of the week
- The post-holder will travel regularly between Council buildings, schools, partner agencies and other locations.
- The post holder will be required to attend meetings including Team meetings and visit schools and in some cases work outside of normal working hours. Reasonable notice will be given and the post holder is expected to be flexible wherever possible.
