The Role

The Senior Social Worker's role is a pivotal one within the Strengthening Families Team of our Adoption services and is key to ensuring PACT's professional practice continues to be delivered to a high standard.

The postholder's core function is to provide and manage the specialist placement support services for adopters and their children. As an experienced professional, the postholder is also responsible for coaching and mentoring less experienced practitioner(s), providing day to day support with cases as required.

This post forms part of our overall adoption support service that we offer to all our PACT adoptive families. The role itself is specifically set within our therapeutic social work support team (Strengthening Families Team).

As part of the Strengthening Families Team, this role will also involve the postholder carrying out some individually tailored and in person packages of therapeutic work with adoptive children and their adoptive parent/s.

The postholder will also get involved in helping to plan, set up and co-deliver some inperson therapeutic group work sessions (known as Adoptee Voices) on a regular basis. These groups are specifically set up for our older adoptive children/young people and they also form part of our wider adoption support offer.

Key Tasks

Safeguard and protect vulnerable adults and children in accordance with PACT's Policies and Procedures at all times Undertake evidence-based post placement support assessments which provide a robust analysis and summary of the support needs that adopter(s) and their child/children may require Provide therapeutic support, advice and guidance to families and children throughout their adoption journey. Families can be referred in for such support at any stage of their adoption journey from pre-placement, through to placement itself and then post placement through to Adoption Order and beyond Be the designated 'skills and knowledge lead' within the department for a particular business function – in this case Placement Support for adopters. Share practices with colleagues in the department which benefit service users and PACT Contribute to the development and evaluation of the service, including seeking user feedback and suggesting strategies for future practice Work closely with the FACTS team (Family And Child Therapy Services) by helping to make and process new referrals. You may also be required to support FACTS with the tracking and progress of its funding applications and by ensuring that families are regularly supported and informed about where their funding application is at Be the first point of contact to requests for placement support in 'closed cases' (i.e post Adoption Order) Offer advice and support to PACT colleagues in adoption about placement support issues in open cases and provide expertise and guidance to adopters in the early stages of linking, matching and early placement as required Provide support to recruitment activities for prospective adopters for example, information evenings and drop-in events when required. Participate in other PACT marketing events with others to promote adoption and provide information and guidance to potential future applicants Be involved in preparation and training activities pre and post placement with other team members when required. In addition, takes part in monthly coffee mornings for PACT adopters and monthly support group evenings. Co-ordinate and help to deliver a plan of support and training activities for adopters across all PACT sites post placement and/or post Adoption Order Provide mentoring, advice and support to less experienced staff as directed by the Team Manager

- O Take part in a duty service providing useful and accurate information, answering queries, and informing of appropriate next steps
- O Maintain accurate, clear and up to date case records on CHARMS and provide reports and post placement social work assessments of needs to a high standard, as required
- O Represent PACT as appropriate in interactions with statutory and other voluntary agencies
- Take responsibility for and be committed to personal and professional development and keep up to date with law, regulation, guidance, standards, Government policy and research relating to all aspects of the work including adoption legislation and post placement adoption support services (including therapeutic knowledge and skills)
- O Undertake any other duties deemed commensurate with this post as directed by the line manager
- O Demonstrate and uphold PACT's commitment to equality, diversity and inclusion
