#### JOB PURPOSE

To provide an effective and efficient teaching service to the Mathematics Department.

#### MAIN DUTIES / RESPONSIBILITIES

- To prepare, teach, mark and evaluate pupils' work according to the Mathematics Department and school policies.
- To be able to teach KS3 and KS4 Mathematics and A-level Mathematics and Further Mathematics as required.
- 3. To keep detailed records and evidence of pupils' progress to inform target setting and the reporting cycle.
- 4. To attend Maths Department meetings.
- 5. To play an active role in developing and implementing departmental policy.
- 6. To keep informed of curricular developments in Mathematics.
- To keep informed of whole school policies and to play an active role in implementing them.
- To carry out the duties of Form Tutor (as directed) as outlined in the role description.
- 9. To attend pastoral meetings and play an active role in developing and implementing year-team policy.
- 10. To attend appropriate parents' evenings.
- 11. To carry out a share of supervisory duties in accordance with published schedules.

- 12. To participate in performance review and development procedures.
- 13. Any other duties as directed by the Head of Maths or Leadership Group members.

### General

#### Safeguarding

Safeguarding students of the Trust is a priority. All appointments to posts in the Trust are made through stringent adherence to the requirements of 'Keeping Children Safe in Education' (most recent edition). The schools in the Trust maintain a cohort of staff trained in Safer Recruitment and the trained colleague(s) most appropriate to this post will participate in the selection process.

All staff will be trained annually in Child Protection requirements. Cognisant of Part 1 of 'Keeping Children Safe in Education', (most recent edition), staff are required to refer all Child Protection concerns to the Child Protection trained staff team in their school (recognising that they can refer directly themselves to LWBF in extraordinary circumstances).
